## Notice of Surcharge Update

Dear Valued Customer,

Thank you for your continued support and for choosing Ocean Network Express (ONE) to cater to your needs.

This is an update to our Notice of Surcharge Update dated July 12, 2024, with regards to the application of Equipment Management Charge (EMC). Please kindly be advised that the following changes will be made.

- 1) The Surcharge shall be **renamed to Local Other Fees (LOT)**.
- 2) Pay Term shall be applicable as Prepaid/Collect in Malaysia.
- 3) Effective start date shall be moved to September 28<sup>th</sup>, 2024; Billing under EMC shall not commence.
- 4) The Surcharge is to cope with the increased Equipment Management complexity & cost in Malaysia.

The new level will be applicable as Prepaid/Collect on all outbound/inbound shipments in Malaysia across all trade lanes and services and will be valid till further notice.
